Dear Clients and Friends,

Last year saw the historic election of President Donald Trump, which seems to have set off or accelerated nationalist movements all over the world. The Brexit vote, for example, represents one of many nations no longer interested in the European Union. Britons voted to manage their own affairs rather than be dictated to by unelected officials who don't even live in that country. One of the least publicized nations trying to win back sovereignty is the Catalan region in eastern Spain. I don't know much about it, but over 90% voted for independence from Spain. The dishonest mainstream media has done a great job of keeping this quiet, which is one of the reasons they are in big trouble.

I believe 2018 will begin the dismantling of the mainstream media. A front-page news item right now is cryptocurrencies like Bitcoin, Ethereum, and Litecoin. In the last month, these seem to have taken off like a racehorse.

Let's start with the basic question: What is money? Simply put, it is a *faith-based representation of value trade*. Expanded a little, it is a *substitute commodity* in which at least two parties can agree to settle an *assigned worth*-oriented exchange that is *not bartering*. Bitcoin has *no central authority*, and this is its *key attraction*.

If you think the exposure of the mainstream media and the political upset in 2017 were big, just wait until you see what cryptocurrency does. This will kick off a new revolution! Check out this show featuring expert [Aaron Brickman](#) and decide for yourself if Bitcoin is for you. The era of the 99% is beginning and the decimation of the 1% is almost complete as a *massive substitution* takes place in how we do business. It will take about one generation, or 25 years, to adapt to this change. Not even 2% of the globe has begun using cryptos since their inception in 2009, so the boom is still ahead.

Remember when the internet started in the 90s? Not many people used it for the first ten years, but now that a generation has passed, the majority are online and familiar with it. I predict that by the end of this decade, it will hit a critical mass, not because of its novelty but because *necessity demands it!* www.coinbase.com, one of the leading exchanges, is adding 100,000 accounts *A DAY!* It has already passed mega broker Charles Swab. Coinbase plans to increase their staff by a mind-boggling 15 times in 2018, with 24/7 customer service across the globe.

I'm not currently participating because its daily volatility is beyond belief. I'm talking corrections of 10–20% (\$5,000 on average) and as high as 90%. Also, there have been instances of it disappearing, as well as power and internet outages. If you must get into it, be sure to use money you are prepared to throw away and not the grocery fund. Don't be emotionally swayed by the predictions of \$1 million Bitcoin by 2020, as it's too easy to be bullish when everything's looking up.

But I'm encouraged that for the first time in history, we are seeing a 24/7, 365-day market in real time that has no elite involvement. Friends, if this is any indication of what the free market looks like, then *WOW!* The future is bright, and the lower and middle classes will have a real chance to do well in the world. I don't give financial advice, but I'll be

spending the next few years studying this and networking with experts to understand it better. Because this is going to change the world, I'll be sure to keep you informed, as the tax rules will be sure to change with it.

If you're looking for a unique Christmas gift for that person who is hard to buy for, a suggestion I've made in earlier newsletters is dollar-for-dollar coins from the Canadian Mint, something I've been investing in for a few years. Simply put, you are buying silver coins at cost with no expense. Even the postage is free! So, if you buy \$20 in coins, you only spend \$20—that's it! Unlike recent forgeries, these are guaranteed redeemable like ordinary currency in Canada. The bonus is that if silver goes through the roof, they instantly increase in value. Also, all collector coins appreciate over time if kept in proof condition. So it's hard to lose on these. I've been buying almost all I can each year, so take advantage while you can as the Mint stopped making them a few years ago.

Nurse Practitioners Can Now Certify Disability Tax Credit Applications



Great news for those applying for the [Disability Tax Credit](#)! Authorized licensed practical nurses can now certify your application instead of a doctor. With an estimated value of over \$2K per year, it's well worth finding out if you qualify. Also, if you've had the condition for several years, you can adjust returns up to 10 years, so it's not uncommon to get over \$20K.

The key is to have the application properly done with the necessary proof. Right now, the [Minister of National Revenue is setting up advisory committees](#) to help deal with applications more efficiently. Thanks goes to all of you who [protested the backlogs](#). Recent U.S. Tax Cuts Will Affect Us Up Here



Donald Trump's [recent tax cuts](#) will soon put us under pressure to do the same. Not only are personal rates down but also corporate and other rates. Trump's promise to "Make America Great Again" may not be so great for us [if we stay the current course](#).

While this has got [some attention from the Liberal government](#), people from [all classes pay more than enough](#), with [no accountability from those in charge](#). Businesses are already taking desperate measures to make ends meet, such as [adding hidden charges](#), while [employees are being taxed for discounted sales](#). Also, all climate-related taxes like carbon taxes, etc., are a complete fraud. 31,487 American scientists have [signed a petition](#), including 9,029 with Ph.Ds, attesting to this fraud. PayPal to Disclose Some Records to CRA



PayPal customers who have a business account, estimated at 250,000 in Canada, received a surprising email last month. It said, "We're writing to notify you that we have received a Federal Court order

requiring us to disclose information to the Canada Revenue Agency (CRA) about PayPal Business account holders who sent or received a payment between January 1, 2014, and November 10, 2017. To comply with the order, PayPal Canada will make a disclosure to the CRA within 45 days of the date of the order."

CRA to Improve Call Centre and More for 2018



According to you, tax pros like me, and the Auditor General, 2017 was a bad year for client service with CRA. A [detailed report from the Auditor General](#) said that the time to service taxpayers was too long. And, [according to the Knowledge Bureau](#), the AG's report outlined two major issues. One, CRA has been caught blocking more than 50 percent of phone calls in order to misrepresent their ability to meet service standard parameters. And two, CRA provides incorrect information to callers at least 30 percent of the time. This is unjust, and needless to say, [taxpayers should be up in arms](#). Industry professionals will monitor the situation to keep you updated.

92% of Survey Tax Professionals Agree CRA Audits Are Too Over the Top



A [recent survey of 335 tax pros](#) found that only 8% thought CRA was fair regarding tax audits. An overwhelming 92% beg to differ, for the following reasons:

- CRA is targeting low- and middle-income people with legitimate claims who may be unable to afford professional tax services.
- CRA is highly disorganized in requesting further documentation for deductions, belabouring the process.
- Common deductions are requiring additional documentation—moving expenses, medical expenses, and claiming an eligible dependent. In some cases, legitimate

deductions are being disallowed, or the individual handling the files at CRA is unreachable.

- CRA is embarking upon more deep audits, and there's greater activity on pre- and post-assessment reviews. But there are inconsistencies in the documentation requirements year over year. For example, foreign documents even with a simple translation are no longer accepted: CRA now requires fully notarized translations.
