## E-file Finally Available All Year

It's exciting to announce that as of 2013, and for the first time in history, E-file will be available year-round for personal returns. This year it will only be available until November 30, but after that it will not shut down outside of normal maintenance. Does it get any better? Here's the bonus. Also, as of the New Year, you can file previous returns if you're behind up to four years—with only one catch: 2012 will be the first year you can backfile, so if you happen to be behind up to 2016, then you can do all four years in one shot and thereafter. Now that CRA has you confused, the simple rule is this: you can E-file up to four years, but they only accumulate starting in 2013. ## 2012 Tax Service Now Available

As I alerted some of you in the summer, 2012 tax preparation service is now available. Those of you who have all your information or are filing zero income can take advantage of this service and avoid the rush. You can get the paperwork from the [forms website](#). Unfortunately, most people will have to wait until early March 2013 when they have all their T-slips, etc. One of the bonuses is that the 2013 calculations are also available (based on current information, of course). So, for example, if a client foresees a sizable amount of money coming from a buyout with the option to defer, it's recommended they book a consultation to utilize the most tax-advantageous strategy. I have done several of these and have saved clients untold thousands with a brief planning tactic. Unfortunately, many people end up paying too much tax on severances because they are not properly informed on how to address this!



## Tax Fraudster Sentenced to 12 Years in Jail

Over the summer, the kingpin behind a multi-million-dollar tax-preparation fraud was sentenced to over 12 years in prison. While most of the scheme took place in the United States, hundreds of Canadians fell victim to him. It was estimated that over \$763 million was claimed in refunds, but only \$14 million was paid out before his arrest in 2010. ## CRA Discontinues TELEFILE Service

This was the last year that individuals could [TELEFILE](#) their personal returns over the phone. This comes as no surprise, since only 1.2% of Canadians use this service, compared to the whopping 66% who file electronically. TELEFILE was more popular in the 1980s and early 90s, when commercial e-filing was just getting going and was not yet available to the public as it is today. The effective date was June 27, 2012. ### Are You Really, Really Behind on Your U.S. Taxes?

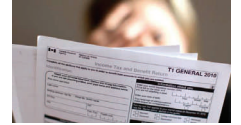
Thousands of Americans in Canada and abroad are scrambling to understand the recent tax crackdown by the U.S. Internal Revenue Service (IRS). Recently, the IRS brought some welcome relief to those who are missing returns. While current tax treaties are designed to avoid double or over-taxing, all U.S. citizens are required to file returns with Reports of Foreign Bank and Financial Accounts (FBARs) regardless of where they live, and must report their worldwide assets. The IRS will allow taxpayers they consider to be low compliance risks to get caught up without facing penalties or additional enforcement, provided they have simple tax returns and owe \$1,500 or less in taxes for any of the covered years. ### No More Tax Packages in the Mail as of 2013

2012 was the last year you'll get those annual notices in the mail from CRA to file your taxes in the New Year. To reduce expenses, and because of advances in e-services, CRA will no longer be using paper reminders. Those wishing to file their own return can [download the forms](#) or [Net file](#) online. I have little money to pay someone, let alone pay the taxes I owe. Every time I start to get my taxes together, I run out of money and the accountants eventually get rid of me for lack of co-operation. To top it off, I find it hard to keep a roof over my head, and even my own parents don't want me in their house. I'm 47 years old and many people think I've lost my marbles. Not only am I losing hope, but I doubt I'll ever get this behind me. Can you help?

Dear Brett,  
Marbles can be found, and while your case is serious, it is by no means the worst I've seen. You must understand that a shortage of money is only part of the problem. The real

issue is that you refused to get on with things when you had the money. There's only one way to tackle this: find an accountant who will work with you and agree on a payment plan for their fees, and then stick to it. It's much cheaper to prepare the paperwork than use a bookkeeper. Our [Small Business Tax Booklet](#) and [Excel business spreadsheet](#) can help you with that. Sometimes, to settle your account, you can submit a consumer proposal to pay the outstanding balance to CRA through a bankruptcy trustee. Good luck!
