Tax Rules Apply to Digital Currency Like Bitcoins



The CRA recently issued a <u>bulletin</u> <u>about tax implications</u> for virtual

currency like <u>bitcoins</u>. While there is no law against nongovernmental currencies, the CRA takes the view that such transactions fall under the <u>barter regulations</u>. Digital currencies can be hard to evaluate since there are no official standards as to what they are worth at a particular time. So it is the taxpayer's responsibility to prove the <u>worth of the</u> <u>transaction</u>. Most transactions will be subject to taxes but some may not, so check out the <u>CRA webpage on</u> <u>exemptions</u>. For further information, contact the general enquires line at 1-800-959-8281.

with their enterprises. Some of the <u>highlights outlined by the</u> <u>Minister of Revenue</u> for 2013 are:

- <u>A new CRA Red Tape Reduction Action plan webpage</u> that gives businesses up-to-date information on the CRA's progress.
- <u>A new online mail service for Canadian small businesses</u>. Businesses can now communicate with the CRA online, which will help streamline their interactions with the CRA.
- <u>The My Business Account online enquiries service</u>.
 Businesses or their representatives can ask the CRA tax-

related questions about their accounts online and they will receive answers online and in writing.

- <u>A one-stop-shop webpage for business services</u>.
 Businesses can now easily find information and service options relevant to their tax situation.
- Agent ID for the CRA's business enquiries telephone service. Now, when a business owner calls the CRA, the agent who answers provides an ID at the beginning of the call. The Agent ID number provides increased accountability for business calls to the CRA, ensures a consistent experience for callers, and makes it easier for business owners to give feedback on CRA services.

Freeman on the Land: Legitimate Sovereignty or Lawless Vagabonds?

Dear Neel,

I've been approached about joining <u>Freeman on the Land</u>, and I'm not sure whether it's a fraud or a genuine movement. Some things seem to make

sense, but I have no idea how to tell. Can a person actually not pay taxes and get a whole bunch of free things just because they are natural to the country?

Dear Tom,

When someone promises something of considerable value for free, alarm bells should sound right away. <u>Freeman on the</u> <u>Land</u> recently got press when a <u>landlord in Calgary had to evict</u> <u>deadbeat tenants</u> who claimed embassy status on her property while refusing to pay rent. While I'm not directly familiar with this caucus, it seems to come out of the <u>Sovereign Citizen Movement</u>, which believes it is optional to acknowledge the elected government and its laws and they have no obligation to comply.

While some conspiracy theories may have some validity if studied carefully, you can be sure that this movement is a complete fraud and publicly dangerous. In 2012, Alberta Justice John Rooke <u>lambasted the Freeman idea in a 185-page</u> <u>ruling</u>, exposing it for what it really is and creating a set of rules for dealing with people who wreak havoc in our courts. In a later, similar case, Rooke said that the litigant "is not entitled to simply make up what he wants the law to be." This is at the centre of Freeman values, and it won't fly, even if there is some validity.

Personally, I find those involved in this movement irresponsible. Not only do they not pay taxes, but they are also more interested in their perceived rights than in their obligations, and they refuse to pull their weight, <u>arrogantly</u> <u>taking other people's property</u> whenever they feel like it.

This is nothing new. In fact, it's one of the oldest tricks in the book. While some of their ideas may be interesting, like understanding how the legal system works, their philosophy can't possibly function in any system.

In short, Freeman is a scam that preys on the vulnerable and uninformed. Recognized independent organizations like the <u>Canadian Taxpayers Federation</u> and <u>Fraser Institute</u> study government policy and criticize issues publicly where appropriate. Neither of them, or any established federal or provincial political party, gives any credence to the Freeman movement. So you can feel confident that it's a hoax that will ultimately find its way into the hall of shame. My hope is that there will be minimal casualties along the way. I applaud you for taking the time to look into this.

The first artificial Christmas trees were wooden, triangular-shaped pyramids lit by candles. They were developed in Bethlehem, Pennsylvania, in 1747 by the German Moravian Church.
