2010 seemed to be a turnaround year and in Canada 2011 appears to have some good news. While were certainly not out of the woods like a few years ago, positive signs are everywhere. North American auto companies have come back in the black and in the west, real estate is doing a booming business especially in the Vancouver area. The 2011-2012 Federal budget is expected to be out in a few weeks and while not a lot of change is expected, it is likely low income <u>seniors</u> will received higher <u>Guaranteed Income</u> <u>Supplements</u>. This is good news to the elderly whose investments were hit in the downturn and with Canada's population again, we can expect more attention in benefit payments and tax breaks to this demographic.

Today, you either have to become an expert in this field or get experts to work for you. I have often chosen the latter in my life and while it may seem costly in the beginning, it turns out to be a bargain in the long run and lower stress to boot.

In this "sweetheart" season, one observation comes to mind. I have yet to meet many experts who hate what they do and in fact, the opposite seems to be true. You may have heard the saying "If you love what you do, you'll never work a day in your life?" Actually most of that is true because I don't believe there's any perfect job in this world. But without a doubt, there's a vast, vast difference in service between those who are "passive" about their "work" compared to those who wake up with "passion" for their "calling". As a matter of fact, I even feel that way about many of my <u>off duty pursuits</u> <u>like astronomy</u>.

Folks, let me give you some free advice even though were well past New Year's Day (and by now you broke all the resolution anyway!). If you hate getting up in the

morning because you can't stand the next 8 hours or those lovely folks, politics and more, stop wasting time and consider some serious change. We've been in a new decade for over a year now and the changes before us I don't even think we can begin to appreciate.

The 1900's was the industrial/large corporate century but I believe the 2000's will be the century of the entrepreneur. No longer do we need huge capital and a lot of red tape to get going in your own enterprise. Technology, falling trade barriers and most important "immediate customer needs" is driving people into their own business. In 1998 when I first started PTC Canada, about 50% were selfemployed or in business. What happened to those who didn't believe me in the 90's about getting a computer? Who knows and regrettably many won't care. It's tragic when we don't give any credence to those who dedicate themselves to a particular calling but unfortunately that's their problem and bad luck. Personally I choose to trust those who are rightfully called because even if they're a bit early in the day, there's a very good chance their right.

One of the other sleeping giants is a massive (and I mean massive), sudden shift from employment to selfemployment which I believe will sprout wings in this decade. GM in its glory days of the '70s had over 400,000 employees in the US, but today is less than 100,000 and many retirees will not get replaced. This will be a contiguous trend in North America not only for blue collar workers, but across the board. Today's companies are no longer based on the "lifetime employment" model of the last decade and because people still have to work for most of their life, individuals are more open to the risk of starting their own business.

PTC Canada has been well prepared for this and will continue to do so. The combination of a changing labor force, complex tax world and growing technology is a problem for many but music to my ears. I'm very passionate about servicing my clients and committed to this business, so I'll be here a long time with the associates who help make it happened. At the end of last year CRA released the comparative figures for 2010 and 2011 for tax brackets, nonrefundable credits, exemptions, GST credit, and other benefits. Each year, certain personal income tax and benefit amounts are indexed to inflation using the Consumer Price Index data as reported by Statistics Canada. #### **RRSP** Deadline Approaching!

This year's contribution deadline is Monday, March 01st, 2011 for your 2010 income tax return. If you miss the deadline, you can always use it for your 2011 return. You should make sure you have relevant information like your contribution room, Home Buyer/Lifelong Learning Plan repayment requirements and so forth. #### "E-File" Ready for 2010 Personal Returns

It's official. "E-File" starts first thing today, Monday, February 07th, 2011 for all 2010 personal returns. Most refunds are in 1-2 weeks and I suggest you get direct deposit. When you file your return simply take your banking information or a blank check and you can have your refund, GST Credit and Child Tax Benefits all done. If for some reason you forget, simply file the Direct Deposit form with CRA and they should be able to start in 1-2 months. Corporations can "E-File" all year round up to 4 years back and can do direct deposit via the Corporate Direct Deposit form.

#### Minister of National Revenue to Ensure Taxpayer's Right Honored

Just before the New Year started, CRA was under fire from Paul Dubé, the Tax Ombudsman because many taxpayers felt their rights were being denied for no good reason based on his report "The Right to Know". Since then Keith Ashfield, Minister of National Revenue has decided to implement all of the recommendations based on the report called "Proving your Status". #### Tax Free Savings Account Update

There's seems to be more interest in the "Tax Free Savings Accounts" (TFSA) introduced over 2 years ago. While I'm not an expert in these, here are a few things you should know about them:

A TFSA can be made up of an array of investments. Your TFSA can contain different types of investments, similar to those in a Registered Retirement Savings Plan, such as Guaranteed Investment Certificates (GICs), bonds, mutual funds and stocks. Contact your financial institution for more information concerning eligible investments.

TFSA contribution room accumulates every year. The maximum TFSA contribution room for an individual was \$5,000 for 2009. For 2010 and 2011, your available TFSA contribution room is made up of three components:

- Your annual TFSA dollar limit of \$5,000,
- Your unused TFSA contribution room from the previous year, and
- The total amount of withdrawals from your TFSA made in the previous year.

#### Prime Minister Committed to Reducing Red Tape

Does it seem to take forever to get the right answer or something done from the Federal Government? Stephen Harper seems to agree so last month they announced a new initiative to reduce obstacles by forming the "Red Tape Reduction Commission". Considering it cost \$30.5 billion dollars (that's 1.9% of the GDP) on regulatory compliance tasks in 2008, there's lots of incentive to reduce bureaucracy. #### Power of Attorney with CRA

In the past, having "power of attorney" for your tax professional could become a very involved process if you needed them to undertake particular tasks like changing an address, etc. Unfortunately, the CRA restricted several activities a representative can do for you until recently, even if you gave full consent. This year, a taxpayer can authorize their tax professional by filling out the <u>new consent form</u> and ticking off the "power of attorney" option in part 6. If you find this complicated, we can do this for you and any other members of your family at no charge.

#### 2011-The Year of the Entrepreneur

#### Dear Neel,

I haven't filed my returns in several years and I've run my own tanning salon which is incorporated. My accountant says it's more tax friendly to pay dividends rather than salary when I draw money out. Is this true and are there downsides to this? Dani J.

Dear Dani J.,

Dividends are certainly an option, but keep in mind CRA views them like an investment payout like interest, etc. and is not considered "earned income". Therefore, you cannot claim expenses like daycare, moving expenses and your RRSP contribution room does not increase amongst other things. I cannot give you specific recommendations on how to report it because you didn't mention how money was taken out of the company. Most accountants will recommend the most tax friendly route and assuming you owe taxes after all those years, it's probably the way to go. # **Celestial Treat-Check out The "Valentine" Star!**



Have you ever wondered if there was a celestial object named after the saintly love day? The fact of the matter is a resounding "YES", there is a Valentine Star and it is more commonly known as <u>Betelgeuse</u> (pronounced beetle juice) a favourite of many astronomers! So why is it the Valentine's Day Star? A telescope will reveal its red colour, beats slowly like a giant heart and stimulates the spirit of those attuned to it. The prominent object we can see every February 14<sup>th</sup> is this bright scarlet star because it's at its highest point above the horizon every Valentine's Day night between the hours of 8 and 9 p.m. It marks the shoulder star of Orion and it changes its size regularly like a slow pulsating heart that beats once every 6 years. Now when Betelgeuse is fully contracted at its smallest size it is a whopping 500 times the width of our Sun but when it expands to its biggest size it is almost 900 times as wide.

Betelgeuse is an extremely large red super giant star, fluctuating in approximate size from the equivalent of Mars' orbit, to that of Jupiter's, so it's monstrous compared to our puny yellow Sun. It is the second brightest star in the constellation Orion and the ninth brightest object in the night sky. It is a vertex of the Winter Triangle and center of the Winter Hexagon. It is possible that Betelgeuse will become a supernova, which will be the brightest ever recorded, outshining the Moon in the night sky. Considering its size and age, it may explode within the next thousand years. Since its rotational axis is not toward the Earth and also because of its 640 light year distance, Betelgeuse's supernova will not cause a gamma ray burst in the direction of Earth large enough to damage its ecosystems. Therefore, this February after you get the chocolates and flowers, surprise them with first a picture of the giant red star, pulsing like a heart full of cosmic love and then show them the real deal that evening. Believe me they'll remember it the right way. The Valentine's Day star is visible February 14<sup>th</sup>, 2011 starting in the North American SSE sky after sun down and setting in the West around 04:00 am.
