




RRSP Deadline Approaching!

This year's contribution deadline is Monday, February 03th, 2025, for your 2024 income tax return. If you miss the deadline, you can always use it for your 2025 return. You should make sure you



have relevant information like your contribution room, Home Buyer/Lifelong Learning Plan repayment requirements, and so forth. 
More & Improved E-Services for 2024 Personal Returns

It is official. "E-File" starts first thing
Monday, February 24th, 2025, for all 2024 personal returns.
Most refunds are in 1-2 weeks, and I suggest you get direct deposit. Also, there are a variety of slips now available online as far back as 10 years with online mail, and now you can link between My Account and My Service Canada Account with more. When you file your return, simply take your banking information or a blank cheque and you can have your refund, GST Credit, and Child Benefits all done. If for some reason you forget, simply sign up for Direct Deposit with CRA and they should be able to start right away. For further information contact general enquiries at 1-800-959-8281.


2024 Fall Economic Statement

Mandatory Digital Communications Start in 2025

CRA has had <u>digital services</u> for over 20 years now and while it took about 10 years

for a considerable portion of the public to come on board, pretty well all are signed up by now. No surprise, it's now mandatory for all to sign up, and while I still run into the odd one who hasn't, it's nearly impossible to interact with CRA now. New Capital Gains Rules Deferred to 2026



The proposed <u>capital gains tax</u> rules have been <u>postponed until the New Year 2026</u>. Currently you pay tax on 50% of your net gain, regardless of the total gains. Also, the <u>Lifetime Capital Gains Exemption</u> will increase to \$1.25 million. Also, a new Canadian Entrepreneurs' Incentive, to encourage entrepreneurship by reducing the inclusion rate to one-third on a lifetime maximum of \$2 million in eligible capital gains will take effect in the 2025 tax year and the maximum would increase by \$400,000 each year, reaching \$2 million in 2029. CRA's new "SimpleFile" are invitation

letters to file your taxes using one of these services: Phone, Digital, or Paper. While the service does target the simpler returns it has not been a hit by any stretch. According to CBC, the program saw "little uptake" while the vast majority filed through traditional methods rather than using the free SimpleFile service. A recent Toronto Sun article quoted Franco Terrazzano, federal director of the Canadian Taxpayers Federation "Trusting the CRA to do your tax return is like trusting your dog to protect your burger, taxpayers want to keep as much of their own money as possible, while the CRA wants to squeeze as much money as it can from taxpayers, The government is more than \$1 trillion in debt, it's broke. If the CRA takes over tax filing, expect your tax bill to go up." EXACTLY, it's a trap, and well said Mr. Terrazzano!

I'm beyond frustrated as I have quite a bit of money coming back due to proving my moving expenses and more and can't get an answer or update the progress tracker; any possibility those conspiracy theories

are right, and they've quietly gone out of business?

Dear Nellie.

Whoa on those conspiracies and theories as they're always out there, and I can assure you CRA is very much in business but no doubt there's been a consistent backlog since COVID. Now that the staff are back in the office, the hope is the backlog starts to clear up. The Progress Tracker is a good service which mostly does what it promises, but depending on the complexity of your case, it can go into limbo until they figure

out the solution. My suggestion is to contact CRA at 1-800-959 -8281 and get a tier 2 agent so it will be personally assigned to someone with a direct line and tracking number.

If this is still an issue, fill out the <u>Service Feedback link</u> under the <u>delays beyond current processing times</u> section, and if that doesn't work, contact the <u>Office of the Taxpayers'</u>

<u>Ombudsman</u> at 1-866-586-3839. I've never dealt with them yet but met the chairman at a meeting a few years ago and they seem pretty proactive. Just so you know, I have several clients in a similar situations so you're not alone. On the conspiracy side, I try to follow some but for the most they're nearly impossible to prove.


