New Credits, Benefits, and Services for Your 2022 Personal Taxes

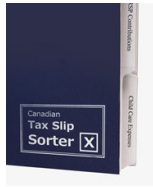

Federal Employees' Raise Demand of Almost 50% is Beyond Ridiculous



Just when you thought you'd seen it all, the people who tax you are now wanting a raise—big too! [According to the Financial Post](#) back in the winter, they're asking "14% per year over three years;" [according](#) to the Treasury Board of Canada Secretariat, "Compounded, this would represent a 47% increase over three years." It's also pushing for 29%, 28%, and 25% increases across its other bargaining groups over three years. I get it's expensive out there and people need to live, etc., but with record homelessness and people in the private sector falling into poverty with no security net, this is beyond the pale and must stop. Taxpayers need to [contact their MP](#) and demand this insanity stops now!

Extended Call Center Hours at CRA

CRA will be open from 8 am to 8 pm Monday to Friday and 9 am to 5 pm Saturday until May 01st, 2023. There is now a "call back" option if the lineup is too long but I will have to wait for feedback to see how successful this was as its brand new. Most still use the on-line services as it is much faster and can cover the bulk of general needs. 2022 Tax Filing Deadline

The deadline is now 29 days for most personal returns and there is no talk of an extension this year. Waiting until the last minute to get your taxes done is never a good idea; especially if you need it assessed soon. Once you are ready to file your 2022 return, plan TODAY rather than April 29th. I am jammed to the rafters with appointments, and you may have to wait weeks before getting a chance. Take advantage of our email, fax, phone, or mail service. Make sure you [authorize us](#) if you have not already done so or are a new client. The days of office locations and 9-5 hours are really becoming a thing of the past and regrettably businesses stuck in yesterday's perception will get left there. Most clients are demanding more options, and no surprise, appointments are no longer necessary!



E-FILE Now Up to 6 Years Back and Heading to 10 Years Soon

Good news for clients behind on taxes is we can now e-file as far as 2017 or six years. [These portals will remain open until it reaches the 10-year mark](#), so 2026 will be the first year 10 years can be e-filed. Also, we can currently download slips back to 2014, when that service started 8 years ago, and I believe once that reaches the 10-year mark in 2024, that will close off slips before the 10-year mark. On-line adjustments currently only go back 4 years but stay tuned to see if that is allowed to follow the same pattern!



Abolishing the IRS Coming to CRA?

I was interested in the new US congress wanting to get rid of the IRS. What does this mean, and will it come to Canada with CRA?

Dear Renee Z.,

You're referring to the Fair Tax Act of 2023 introduced in the New Year which essentially removes most taxes like income, payroll, estate, gift, etc. replacing it with a one-time sales tax of 23% with adjustments, exemptions, etc., starting in 2025. While I applaud the move, it's still a journey to the origins of the US Constitution which is to fund government via tariffs only. Canada is of course different but with the USMCA effective as of 2020, we can expect to be more influenced by US policy than ever before and this of course makes sense. The USMCA mainly addresses trade/tariffs with North America and the rest of the world which agrees with the US Constitution. Internally, it reduces red tape for small business, farmers, enterprises, etc., which are not government related and also agree with the US Constitution.

The USMCA and US Constitution do not support centralization of an economy which is generally a death blow to federal taxing agencies. Independent businesses, states, and local municipalities make their own policies usually averse to the traditional monopolization of past bureaucracies. My prediction is yes, the CRA will be a thing of the past as Canadian policy can't possibly compete with an economy 10 times it's size and the USMCA shows no sign of tiring out. Since COVID, people are now thinking more local, which is a good thing and a further takedown of centralism. Lastly, this will decimate the Banker's Manifesto which has no other purpose than to enslave the population financially. Hope this helps!
